# How do you know if someone consents?

JUST ASK!

"Do you want..?"
"Are you okay with...?"

Most importantly, Respect the answer!

Yes

Do you want to?

### Remember:

Consent to kiss or touch is **NOT** consent to do more. Ask and listen for consent for each sexual activity.

# Let's Get Talking: Informed Consent

#### What consent looks like

Positive consent can look like this:

 Explicitly agreeing to certain activities, either by saying "yes," or another affirmative statement.

"Except in situations where you are unable to give consent, such as being underage, under the influence of drugs or alcohol, or under some kind of threat.

#### It does NOT look like this:

- Refusing to acknowledge a verbal "no," or negative body language and other non-verbal communication.
- Assuming that wearing certain clothing, flirting, or kissing is an invitation for anything else.
- Coercing or forcing consent.
- Pressuring someone into sexual activity because they have given consent before.
- Taking advantage of another person when they are incapacitated or impaired in any way.
- Engaging in sexual conduct with someone under the age of consent. In Utah, this age is 16 for women and 18 for men, within 10 years.

# Your body is yours!

You have the right to determine your boundaries and expect the other person to respect them.

If you don't want to participate in sexual activity, you do not have to!

(Even if they are your significant other, have spent money on you, or you've given consent before.)



Someone under the age of consent, influence of drugs, or influence of alcohol cannot consent to sexual acts.

# How do I report?

#### Title IX Investigation:

- Report the incident to the Title IX coordinator (see below)
- \* Title IX coordinator will investigate
- Ask for any extra help you need. This might include:
  - a no-contact order
  - academic accommodations
  - medical and mental health services
  - an escort
  - assistance in arranging alternative employment

#### Report to the Police:

If you choose to report an incident to the police:

- Title IX coordinator can assist you
- You can decide whether or not you file charges, even after reporting

Sexual Assault is actual or attempted sexual contact without that person's consent and includes 1) Intentional touching of another person's intimate parts or other intentional sexual contact without consent; 2) Coercing, forcing, or attempting to coerce or force a person to touch another person's intimate parts without consent; 3) Rape: penetration, no matter how slight, of the vagina or anus of a person by a body part or an object, or the mouth of a person by a sexual organ without consent.
